NOTICE OF HEARING in the matter of Cancelled Permit 52127

To Whom It May Concern:

Permit 52127, which is currently held in the name of the The Callahan Residence Trust (UDI 1/7); Burko, Billy M. and Teri L. (UDI 1/7); The Callahan Trust (UDI 2/7); PGSF, LLC (UDI 1/7); The Mullen Trust (UDI 1/7); and Baldwin, Kenneth C. And Kemmet, Kasey (UDI 1/7) was cancelled as of August 28, 2024. This permit was cancelled for the Permittee's failure to timely file the Proof of Beneficial Use or an Application for an Extension of Time as provided under Nevada Revised Statute (NRS) § 533.410. The State Engineer has received a written petition from Karen Mullen requesting a review of the cancellation at a public hearing, pursuant to NRS 533.395(2).

Your case is being scheduled for hearing with other Petitions to Review Cancelled Permits based on the date of filing of the petitions. The hearings will begin promptly **at 1:00 p.m. on Tuesday, September 30, 2025, at the Division of Water Resources, Tahoe Conference Room, 2nd Floor, 901 S. Stewart Street, Carson City, Nevada.** Failure to appear at the designated time and place will result in an affirmation of the State Engineer's cancellation.

Hearings will be called in the following order:

- 1.) Permit 75970
- 2.) Permit 87911
- 3.) Permit 74059
- 4.) Permit 89556
- 5.) Permit 52127

Please arrive on time (1:00 p.m.) and be prepared for your hearing when it is called.
