NOTICE OF HEARING in the matter of Cancelled Permits 58947, 62680 (portion), and 63887 (portion)

Dear Mr. Weiss:

Permits 58947, a portion of 62680, and a portion of 63887, which are currently held in the name of Washoe County were cancelled as of May 14, 2025. These permits were cancelled for the Permittee's failure to timely file the Proof of Beneficial Use or an Application for an Extension of Time as provided under Nevada Revised Statute (NRS) § 533.410. The State Engineer has received a written petition from Timber Weiss, agent requesting a review of the cancellation at a public hearing, pursuant to NRS 533.395(2).

Your case is being scheduled for hearing with other Petitions to Review Cancelled Permits based on the date of filing of the petitions. The hearings will begin promptly **at 1:00p.m. on Wednesday, January 21, 2025, at the Division of Water Resources, Tahoe Conference Room, 2nd Floor, 901 S. Stewart Street, Carson City, Nevada.** Failure to appear at the designated time and place will result in an affirmation of the State Engineer's cancellation.

Hearings will be called in the following order:

- 1.) Permit 60351
- 2.) Permit 65780
- 3.) Permits 73000, 73003
- 4.) Permits 81270, 81271
- 5.) Permits 58947, 62680, 63887

Please arrive on time (1:00p.m.) and be prepared for your hearing when it is called.
