NOTICE OF HEARING in the matter of Cancelled Permits 81270 and 81271

To Whom It May Concern:

Permits 81270 and 81271, which are currently held in the name of James and Veronica Bullock, Austin and Tosha Kerby were cancelled as of April 22, 2025. These permits were cancelled for the Permittee's failure to timely file the Proof of Beneficial Use and its supporting Cultural Map or an Application for an Extension of Time as provided under Nevada Revised Statute (NRS) § 533.410. The State Engineer has received a written petition from Tosha Kerby requesting a review of the cancellation at a public hearing, pursuant to NRS 533.395(2).

Your case is being scheduled for hearing with other Petitions to Review Cancelled Permits based on the date of filing of the petitions. The hearings will begin promptly **at 1:00p.m. on Wednesday, January 21, 2025, at the Division of Water Resources, Tahoe Conference Room, 2nd Floor, 901 S. Stewart Street, Carson City, Nevada.** Failure to appear at the designated time and place will result in an affirmation of the State Engineer's cancellation.

Hearings will be called in the following order:

- 1.) Permit 60351
- 2.) Permit 65780
- 3.) Permits 73000, 73003
- 4.) Permits 81270, 81271
- 5.) Permits 58947, 62680, 63887

Please arrive on time (1:00p.m.) and be prepared for your hearing when it is called.

Alternatively, if you would like to attend via Teleconference, please notify our office no later than **two (2) working days prior to the hearing.** To attend via teleconference, you may call in by dialing (775) 321-6111. At the voice prompt, connect to the meeting by entering the Phone Conference ID: 398 310 911#.

You or your designated representative should plan to attend for the purpose of presenting evidence or testimony in support of your position concerning the cancelled permit. You are expected to come to the hearing with an original and one copy of any exhibit that is being offered into evidence for submission to the State Engineer.
