**NOTICE OF HEARING** in the matter of Cancelled Permit 82775 (portion)

Dear Mr. and Mrs. Aldridge:

A portion of Permit 82775, which is currently held in the name of Tommy L. and Teresa Ann Aldridge was cancelled as of April 22, 2025. This permit was cancelled for the Permittee's failure to timely file the Proof of Beneficial Use or an Application for an Extension of Time as provided under Nevada Revised Statute (NRS) § 533.410. The State Engineer has received a written petition from the Permittee requesting a review of the cancellation at a public hearing, pursuant to NRS 533.395(2).

Your case is being scheduled for hearing with other Petitions to Review Cancelled Permits based on the date of filing of the petitions. The hearings will begin promptly at 9:00 a.m. on Wednesday, January 21, 2026, at the Division of Water Resources, Tahoe Conference Room, 2nd Floor, 901 S. Stewart Street, Carson City, Nevada. Failure to appear at the designated time and place will result in an affirmation of the State Engineer's cancellation.
