NOTICE OF HEARING in the matter of Cancelled Permit 86579

Dear Mr. Friedman:

Permit 86579, which is currently held in the name of the Owner of Record was cancelled as of August 8, 2024. This permit was cancelled for the Permittee's failure to timely file the Proof of Beneficial Use and its supporting Cultural Map or an Application for an Extension of Time as provided under Nevada Revised Statute (NRS) § 533.410. The State Engineer has received a written petition from Gregory M. Bilyeu, agent, requesting a review of the cancellation at a public hearing, pursuant to NRS 533.395(2).

Your case is being scheduled for hearing with other Petitions to Review Cancelled Permits based on the date of filing of the petitions. The hearings will begin promptly **at 1:00 p.m. on Wednesday, April 16, 2025, at the Division of Water Resources, Tahoe Conference Room, 2nd Floor, 901 S. Stewart Street, Carson City, Nevada.** Failure to appear at the designated time and place will result in an affirmation of the State Engineer's cancellation.

Hearings will be called in the following order:

- 1.) Permit 77551
- 2.) Permit 92101
- 3.) Permits 40307
- 4.) Permit 86579

Please arrive on time (1:00 p.m.) and be prepared for your hearing when it is called.

Alternatively, if you would like to attend via Teleconference, please notify our office no later than **two (2) working days prior to the hearing.** To attend via teleconference, you may call in by dialing (775) 321-6111. You or your designated representative should plan to attend for the purpose of presenting evidence or testimony in support of your position concerning the cancelled permit. You are expected to come to the hearing with an original and one copy of any exhibit that is being offered into evidence for submission to
